WALK-IN INTERVIEW

Nature Of Work

- Data collection for the research projects and its related works.
- To assist the farm Manager in supervising daily farm operation.
- To assist in all kind of disease treatment and to upkeep health of the Mithun.
- Supervision of farm labours and miscellaneous work whenever arises.
- To maintain farm record keeping etc.

Duration of Engagement:

The engagement of the proposed posts is purely on contractual basis for one year and further extendable for another year or till project completion period whichever is earlier

Terms & Conditions:

1. Application addressed to the Director, ICAR-NRC on Mithun, Medziphema, Nagaland along with duly filled application form as per prescribed format must be produced at the time of interview.
2. The applicant must submit **self-attested scanned copies of relevant documents/certificates along with prescribed application form with passport size photograph affixed. Applicants must bring with them all the original documents at the time of interview for verification.**
3. Only the eligible candidates should come for the interview and must be present 30 minutes before the interview scheduled date/time for necessary formalities.
4. The YPs in ICAR are eligible for 08 days leave in a calendar year on pro-rata basis and 02 restricted holidays as per the rules of Govt. of India/ICAR. They are full time workers and required to adhere to the administrative, financial and disciplinary regulations of ICAR-NRCM. Regular attendance will be maintained.
5. In case of serving candidate, NO OBJECTION CERTIFICATE from his/her employer and experience certificate in original should be produced.
6. Initially the period of engagement will be one year, and further extendable for one more year subject to requirement of the services of the YPs in the organization and satisfactory performance of the candidate after evaluation by the Competent.
7. Positions are purely temporary, time bound, non-regular and on co-terminus basis with the project. Appointment can be terminated on one month's notice.

8. Service of the YPs shall be governed by ICAR revised Guidelines for hiring of technical manpower on short term basis issued vide OM No.Agril.Edn.1-06/2020-A&P dated 4.12.2020 and further clarification issued time to time.
9. The selected candidate shall have no legal right to claim regularization by absorption or otherwise against any regular posts or any further contractual engagement on termination of the project.
10. Shortlisted candidates coming for interview after the specified timing will not be entertained.
11. Canvassing in any form will disqualify the candidature.
12. No TA/DA will be paid for attending the interview.
13. Decision of the Director, ICAR-NRC on Mithun, Nagaland shall be final and binding in all respects.
